2. Ring mop out tightly and apply New Dimensions Stone Impregnator Seal to the stone surface. For non-polished surfaces New Dimensions Stone Impregnator Seal may be applied through a pressurized sprayer (for best results and minimal product waste use a SSS Level Best II Mop).



3. Allow to dry for 20-30 minutes.



4. Burnish or buff with a white or light hair polishing pad to remove excess residue.
